**ORDER**

This Court hereby ORDERS as follows:

(1) This Court has jurisdiction over the Los Angeles Dodgers and related assets and has the authority to issue orders regarding the use, possession, and control over those assets, *see* Fam. Code §§ 6324 & 2045;

(2) The Court finds that the Fox Transaction is in the best interests of the Los Angeles Dodgers and should be consummated immediately;

(3) Respondent is authorized to consummate the Fox Transaction immediately;

(4) The proceeds to be received upon the closing of the Fox Transaction shall be utilized as provided by the parties in their binding term sheet, subject to the further order of this Court; and

(3) Respondent's motion scheduled for June 22, 2011 regarding the Fox Transaction is taken off calendar.
