

Warnings and Notices to the Restrained Person in 2**You Cannot Have Guns or Firearms**

You cannot own, have, possess, buy or try to buy, receive or try to receive, or otherwise get guns, other firearms, or ammunition while this Order is in effect. If you do, you can go to jail and pay a \$1,000 fine. You must sell to a licensed gun dealer or turn in to a law enforcement agency any guns or other firearms that you have or control as stated in item 7 above. The court will require you to prove that you did so.

Notice Regarding Nonappearance at Hearing and Service of Order

If you have been personally served with this Temporary Restraining Order and Form CH-109, *Notice of Court Hearing*, but you do not appear at the hearing either in person or by a lawyer, and a restraining order that is the same as this Temporary Restraining Order except for the expiration date is issued at the hearing, a copy of the order will be served on you by mail at the address in item 2.

If this address is not correct or you wish to verify that the Temporary Restraining Order was converted into a restraining order at the hearing without substantive change, or to find out the duration of the order, contact the clerk of the court.

- In addition to the response, you may file and have declarations served, signed by you and other persons who have personal knowledge of the facts. You may use Form MC-030, *Declaration*, for this purpose. It is available from the clerk's office at the court shown on page 1 of this form or at www.courts.ca.gov/forms. If you do not know how to prepare a declaration, you should see a lawyer.
- Whether or not you file a response, you should attend the hearing. If you have any witnesses, they must also go to the hearing.

Instructions for Law Enforcement**Enforcing the Restraining Order**

This order is enforceable by any law enforcement agency that has received the order, is shown a copy of the order, or has verified its existence on the California Restraining and Protective Orders System (CARPOS). If the law enforcement agency has not received proof of service on the restrained person, the agency must advise the restrained person of the terms of the order and then must enforce it. Violations of this order are subject to criminal penalties.

This order *starts* on the date next to the judge's signature on page 3. The order *ends* on the expiration date in item ④ on page 1.

Arrest Required if Order Is Violated

If an officer has probable cause to believe that the restrained person had notice of the order and has disobeyed the order, the officer must arrest the restrained person. (Pen. Code, §§ 836(c)(1), 13701(b).) A violation of the order may be a violation of Penal Code section 166 or 273.6. Agencies are encouraged to enter violation messages into CARPOS.

Notice/Proof of Service

The law enforcement agency must first determine if the restrained person had notice of the order. Consider the restrained person "served" (given notice) if (Pen. Code, § 836(c)(2)):

- The officer sees a copy of the Proof of Service or confirms that the Proof of Service is on file; or
- The restrained person was informed of the order by an officer.

An officer can obtain information about the contents of the order and proof of service in CARPOS. If proof of service on the restrained person cannot be verified, the agency must advise the restrained person of the terms of the order and then enforce it.

If the Protected Person Contacts the Restrained Person

Even if the protected person invites or consents to contact with the restrained person, this order remains in effect and must be enforced. The protected person cannot be arrested for inviting or consenting to contact with the restrained person. The order can be changed only by another court order. (Pen. Code, § 13710(b).)

Conflicting Orders

A protective order issued in a criminal case on Form CR-161 takes precedence in enforcement over any conflicting civil court order. (Pen. Code, § 136.2(e)(2).) Any nonconflicting terms of the civil restraining order remain in full force. An *Emergency Protective Order* (Form EPO-001) that is in effect between the same parties and is more restrictive than other restraining orders takes precedence over all other restraining orders. (Pen. Code, § 136.2.)





Over the past two months, John Hobbs, who was recently discharged from a mental hospital, has posted a barrage of threatening messages directed to me and my family on various websites. More specifically, Hobbs threatened to kill me and my husband (Alexis Denisof) on numerous occasions, threatened to physically harm me, and suggested that he will rape me. I am in severe fear for my safety and the safety of my family.

I do not know Hobbs, nor have I ever met or spoken with him. Since at least December 2012, Hobbs has been posting messages about me on his Facebook page and on fan websites (I am a celebrity actress). Hobbs has developed an unhealthy obsession, devoted his Facebook page to me, posted at least 50 Facebook messages directed to me and over 100 messages on my fan websites, and posted over a dozen photos of me. Hobbs, who resides in New Hampshire, has threatened to come to California where I live, and kill me and my husband, physically harm and rape me, and has made repeated statements about taking me "up" to the "after-life."

The following are just a sampling of recent posts:

Jan. 3 - "With that said, in 2013 I still can marry you tomorrow. I also can kill you tomorrow too. Cause I simply like and love you as you live life. Aly... It doesn't end. Even after death."

Jan. 5 - "Alyson lee Hannigan-Denisof, IF you really have any questions for me today. I'll be happy to answer them for you. I'm the guy on planet Earth that Likes and love you so much. I can marry you or kill you tomorrow..."

Jan. 5 - "Alyson, If you just totally just Hate me in 2013. I guess that means I'm just going have to kill you rather than marry you. I've always been looking forward to the dance though, not backwards. Aly :)"

I hired Screen International Security Services Ltd. ("SISS") to monitor Hobbs' posting activity. A true and correct copy of SISS's report, reflecting dozens of posts by Hobbs is attached hereto as Exhibit "1." A true and correct copy of his facebook page as of February 11, 2013 is attached hereto as Exhibit "2." Notably, Hobbs has since deleted some threatening messages. True and correct copies of those posts are attached hereto as Exhibit "3."

Moreover, given his incessant threats, the local police department visited Mr. Hobbs at his home in Nashua, New Hampshire. A true and correct copy of the police report is attached hereto as Exhibit "4." The police report identifies a number of posts by Hobbs, including those saying he will marry or kill me, he will see me "up there," and other threatening and obsessive posts.

The police report also notes that, "Hobbs fully acknowledged his interest in Alyson Hannigan. He did not dispute the postings he had put on facebook. He said he was planning to go to California this year and that he did hope to see Alyson Hannigan at that time. When asked what business or pleasure he had in CA he only said he had a few things planned." The police further observe that "Hobbs seemed to be living in an alternate reality."

The police report goes on to state that, "Hobbs agreed to go to SNHMC voluntarily to talk with a Mental Health Clinician when I [Officer Kevin Landry] explained to him that I was concerned about his behavior related to the postings about Hannigan." Even after his visit to the mental health clinic, Hobbs insisted that he was still going to California to visit me.

I fear for my own safety, and the safety of my husband and children. Hobbs has threatened to assault, kill and rape me, and I have suffered and continue to suffer severe emotional distress as a result of Hobbs' conduct. I respectfully request this Court's intervention.

On 6 Jan 13 at aprox. 1145hrs I responded to NPD Lobby for what was listed as Give Advice, The complainant;

was reporting that she had found some concerning and disturbing posts on a Facebook page belonging to her adult nephew whom lives in Nashua concerning what appeared to be essentially an obsession with a female celebrity. The involved subject is identified as;

JOHN HOBBS, age 43
DOB: 69

The obsession according to included postings to the effect that Hobbs 'could either kill her or marry her', 'that he would see her Up there' and indications that he planned to go to California related to his interest in her.

The celebrity is identified as;

Alyson Hannigan

Hannigan is currently a star in CBS sitcom, How I Met Your Mother. She is known for her roles in Buffy the Vampire Slayer and American Pie.

stated that she had very little contact with Hobbs. She had last seen him aprox. 3-4 years ago for about 1/2 hr at a family get together. She believed he lived with his mother Angi, her sister. She reported not really having any contacts with Hobbs other than the get together going back to the late 1980's. She had not talked with her sister in about one year. could not give very specific details about Hobbs. It was unknown to her if her had any mental health issues or other troubled past such as drugs, alcohol or crime.

I located John Hobbs in our Nashua IMC history at the above address. There was little history and no noted criminal or mental health history. He had several entries for Taxi Permit registration including this past year. I noted at Pistol Permit was issued in January 2000. NPD Dispatch upon my request ran an NCIC and III check. There was no history.

was escorted into NPD and logged into her Facebook account where she then opened the account for John Hobbs. His account is public. I began to see numerous posts regarding Alyson Hannigan. She is mentioned just as Alyson and also using the entire name Alyson lee Hannigan-Denisof or Mrs. Denisof. There are references to her husband Alexis. He appears to be given a name by Hobbs of Mr. Evil Poohs. On the first post noted I see Hobbs writes he is getting tired of Mr. Evil Poohs and he thinks that is why he is going to CA this year. There are several other mentions about going to CA. Hobbs says he loves Hannigan and asks her how she feels about him and that he will find out in person. He writes he is seeing triangles where others see circles. Hobbs writes referring to Mrs. Denisof, see you "UP" there, or maybe put you up there. He writes he has been waiting for her 43 years of his life. He writes he is the guy on planet earth who likes and loves her so much and that he can marry her or kill her tomorrow. There are several mentions that he loves her. He writes about having a dance or finishing a dance. He writes Evil Poo does not help the situation by that he can kill her because he loves

her. Hobbs seems to be soliciting for Hannigan to call him. He writes on one post providing his phone number and address and suggesting they talk in person and it seems adds a threat that if she truly wished for peace she should or he would see her first. Hobbs adds that if he sees her first she would not have to worry about next years season of HIMYM and that they would need a replacement for Lily (apparently the character Hannigan plays on the show).

The postings I viewed were 15 pages dating back to 1 Jan 13 so all in the very recent past. I noted several other quotations posted and a few photos of Hannigan also adding to the concern for the apparent obsession. A copy of the postings were printed and submitted for case inclusion. A link was noted for the Fan Page of Alyson Hannigan. John Hobbs can be seen on these pages as well with some posting but nothing to the extent of the above. A copy of 7 pages of said fan page is also printed and submitted for case inclusion.

I met with Det. R. Powers whom assisted with a preservation of the Facebook account for John Hobbs. A copy of the preservation request for <http://www.facebook.com/akeyoflife>, along with the associated facebook page and a corresponding email are submitted for case inclusion.

I met with Sgt. Molinari and he was briefed. We responded to 9 Hidden Trail where contact was made with John Hobbs. Hobbs did confirm residing her in the River Pines Trailer Park along with his mother Angi. She was currently not home and admitted at Southern New Hampshire Regional Medical Center. Hobbs agreed to let us into the home and we began to talk with him. Hobbs fully acknowledged his 'interest' in Alyson Hannigan. He did not dispute the postings he had put on his facebook. He said he was planning to go to California this year and that he did hope to see Alyson Hannigan at that time. When asked what business or pleasure he had in CA he only said he had a few things planned.

Hobbs said he knew Alyson Hannigan and had known her since the early 1980's. He said he first met her when he was attending Camp Merrymeeting in Alton, NH. He said he had stayed with relatives around the time of the camp at a trailer park in the area. He said Hannigan, then age 15 months old was also staying there with some relatives. He said he met her then. He said her family, the Oulettes were originally from this area somewhere in northern NH.

Hobbs said that he later went to Camp Fatima in Gilmanton, NH with Hannigan. He said they had been friends since. When asked if he had contact with Hannigan currently he said he had not talked with her since about 1993. He said she had been busy with her career and had gotten married. He said he was planning to re connect with her soon and anticipated it was likely. He was hopeful that there was still a connection. When asked if he knew Hannigans current home and other contact information he said he was not sure but that they would still get together. He said he last knew she was in Cottonwood, California. When asked where in CA he was headed he said 'here and there and all over'.

Hobbs seemed to be living in an alternate reality. He began talking about being traveled from when he was in the military. He began talk about a 'thing' he saw in the lake in England that 'was very interesting' and said it was in the lake now in Gilmanton. When asked what the thing was he only added, "it's a thing".

Hobbs was un employed at this time. There was no indication of any weapons in the home. He denied owning any firearms. When asked about the previous pistol permit he said he had been an armed security guard for just a short while and needed the permit. He said the gun was turned back in to the company when he was not working for them any longer.

Hobbs agreed to go to SNHMC voluntarily to talk with a Mental Health Clinician when I explained to him that I was concerned about his behavior related to the posting about Hannigan. Hobbs indicated he currently had no mental health counselor and took no medications. Hobbs was transported by AMR Ambulance voluntarily to SNHMC for further evaluation. I briefed both Ambulance staff and staff at the ER. The nurse assigned was RN Lisa Nelson. She was provided with a copy of the Facebook posting as stated above.

On the morning of 7 Jan 13 I checked in at SNHMC. Hobbs had been released with discharge instructions for follow up at Greater Nashua Mental Health. I talked briefly with Balcom whom indicated she saw Hobbs was still active on the Facebook account and was still making indications of a trip to CA.

Upon request I was connected to Security. I first talked with Supervisor John Hallahan, ph. 212-975-3822 and he was briefed.
